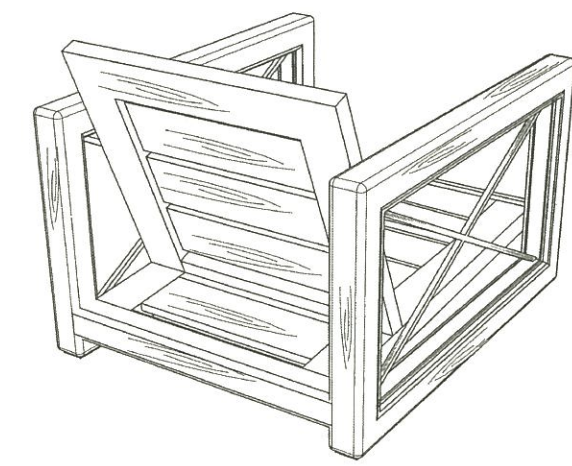
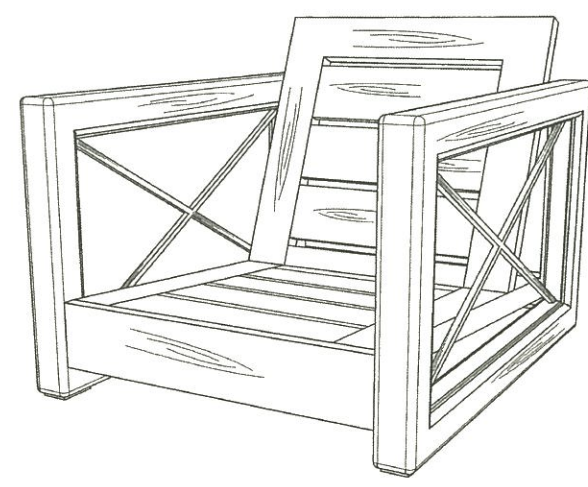

(57) **CLAIM**
The ornamental design for a lounge chair, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of the front and side of the lounge chair showing our ornamental design.
FIG. 2 is a perspective view of the rear and side of the lounge chair.
FIG. 3 is a side elevation view of the lounge chair, the opposite side being a mirror image thereof.
FIG. 4 is a rear elevation view of the lounge chair; and, FIG. 5 is a front elevation view of the lounge chair.
The lounge chair is intended to be used with a seat cushion which is not depicted.
